The Department is proposing changes to following IDAPA chapters:

IDAPA 16.06.08, “Rules and Minimum Standards for DUI Evaluators”

Chapter repeal

IDAPA 16.07.01, “Behavioral Health Sliding Fee Schedules”

Remove reference to the Interagency Committee on Substance Abuse Prevention and Treatment

IDAPA 16.07.17, “Alcohol and Substance Use Disorder Services”

Remove references to the Interagency Committee on Substance Abuse Prevention and Treatment and realign rules with IDAPA 16.07.20

IDAPA 16.07.20, “Alcohol and Substance Use Disorders Treatment and Recovery Support Services Facilities and Programs”

Remove references to the Interagency Committee on Substance Abuse Prevention and Treatment; updates/revisions to accommodate the current substance use disorder treatment environment, integration with Mental Health and changes in health care standards; streamline provider requirements

The proposed changes will be published in the Idaho Administrative Bulletin on **Wednesday, September 5, 2012**. Once published, Dockets of the proposed rule text will be available on the Idaho Department of Administration website at:

Please note that the public hearing is an opportunity for the public to comment on the proposed changes but will not be interactive and will not involve discussion or negotiation of the proposed changes. The published Dockets will only include those sections of the rule where changes are proposed; any section of rule that does not have changes will be “closed” and not open for comment at the public hearing. If individuals have changes they would like to make in parts of the chapter that are not open they can submit a written request for rulemaking to Department’s Administrative Procedures Section. Information on how to submit written comments will be included with the published Dockets.

SUD staff has received many comments and suggestions for revisions from providers, partner agencies, the Courts and other stakeholders and would like to thank everyone for their feedback.
