HOW DO I ADD A NATURAL (BIOLOGICAL) FATHER TO AN IDAHO BIRTH CERTIFICATE WITH A VOLUNTARY ACKNOWLEDGMENT OF PATERNITY?

Paternity of a child may be established if the natural parents complete and file a voluntary acknowledgment of paternity. After paternity is established, the father's information may only be removed by a court of law. Do not sign the voluntary acknowledgment if you are uncertain of paternity of the child.

If the mother of a child born in the state of Idaho is **not married** at the time of conception, birth, or anytime between the conception and birth of the child, the biological father's information can be entered on the birth certificate upon receipt of a properly completed Acknowledgment of Paternity Affidavit signed by the mother and the biological father in the presence of a notary public.

Per Idaho state law, if the mother of a child born in the state of Idaho is **married** at the time of conception, birth, or anytime between the conception and birth, her husband is the legal father and his information must be entered on the birth certificate unless this office receives a properly completed Acknowledgment of Paternity Affidavit signed in the presence of a notary public by the *biological* parents and the legal father (husband) stating that he is not the biological father of the child. Upon receipt of this affidavit, the biological father's information can be entered on the birth certificate.

The Acknowledgment of Paternity Affidavit can be completed at the birth facility at the time of the child's birth, or it can be obtained from:

- Hospitals and birthing facilities
- Local offices of Idaho Child Support Services

If any party cannot be located or refuses to sign the Acknowledgment of Paternity Affidavit, it will be necessary to provide a court order that; (1.) determines paternity of the child or (2.) excludes the legal father (husband) as the biological father. If the natural parents of the child have married **after** the birth of the child and the mother was not married to anyone at the time of conception, birth, or anytime between the conception and birth of the child, the **biological** parents can complete an Acknowledgment of Paternity and Subsequent Marriage Affidavit. This form will allow the biological father's information to be entered and allow the mother's married surname to be reflected on the birth certificate. If the mother was married to someone other than the biological father at the time of conception, birth, or anytime between conception and birth of the child, a three party Acknowledgment of Paternity Affidavit (described above) or court order that excludes the legal father (husband) is required to be filed before filing this document. A certified copy of the marriage certificate is required to file the form unless the marriage occurred in the state of Idaho.

NOTE: FURNISHING FALSE OR FRAUDULENT INFORMATION AFFECTING A CERTIFICATE IS A FELONY AND MAY BE PUNISHABLE BY A FINE OF NOT MORE THAN FIVE THOUSAND DOLLARS (\$5,000) OR IMPRISONMENT OF NOT MORE THAN FIVE (5) YEARS, OR BOTH

Provide a signed written request to process the paternity acknowledgment along with current identification of the person who signs the request. Your request also needs to provide the following information:

- Name of the child as it is currently listed on the birth certificate
- Child's date of birth
- Child's place of birth
- The mother's full maiden name and the biological father's full name
- Your relationship to the person(s) named on the certificate
- Your return address
- Your daytime telephone number

There is a \$20.00 legal amendment fee to file a paternity action. The legal amendment fee does not include a certified copy of the certificate. Certified copies of the birth certificate are \$16.00 each. The Idaho Vital Statistics Certificate Request Form* may be used to request a copy of the certificate, if desired.
